Abstract Submission

Proposals are invited for concurrent sessions and workshops. Submissions may focus on clinical practice, education, evidenced-based practice, research, theory, administration and political aspects associated with the implementation and integration of the role and practice of nurse practitioners. All submissions will be reviewed by a selection committee for quality, relevance and scientific merit. Structured abstracts of 300 words or less are required for each submission.

All communication will be with the primary author only. Oral presentations for each concurrent session will be 60 minutes, including a 15 minute question period. Workshops may last from 60 to 150 minutes and present topics more suitable for longer presentations such as hands on, skills based topics.

Submit one original copy by February 26, 2010 by 1pm EST. Authors will receive email notification of receipt of submissions.

An email notification of the decisions of the review process will be sent by March 26, 2010.
